Subject: Michigan Seamless Tube REACH Compliance

Dear Valued Customer,

Introduction: Michigan Seamless Tube is a producer of cold finished seamless steel tubes and pipes that can be imported into the European Union (EU). In order to document compliance with the EU Regulation (EC 1907/2006) on the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH), Michigan Seamless Tube has prepared this document based on careful consideration of "REACH Guidance for the European Steel Industry", Version 7.1, September 2009, published by the European Confederation of Iron and Steel Industries (EUROFER), and "ECHA Guidance in A Nutshell – Requirements for Substances in Articles"-Version 3.0 issued December 2017.

Discussion: Michigan Seamless Tube produces cold finished seamless steel tubes and pipes that meet the definition of "articles" under the REACH directive. Pursuant to REACH Article 7, our products are not subject to registration as they do not have any intentional release of substances into the environment, nor do they contain any of the **250 Substances of Very High Concern (SVHC)** on the Candidate List included thru June, 2025. Since the raw material used by Michigan Seamless Tube is not intended to be re-melted it is not required to be registered. The products sold by Michigan Seamless Tube are considered to be a semi-finished part. And while further customer processing may require the product to be re-melted, in Michigan Seamless Tube's final state, the material has undergone no re-melting.

Products sold by Michigan Seamless Tube are often protected by a surface treatment such as a rust-inhibiting oil or an Ultraviolet cured coating. Surface treated articles are also not subject to registration based on "EUROFER Common REACH Questions and Answers," published June 2009. In both of these cases, the surface treatments do not contain any of the SVHC as listed above, and the individual SDS can be downloaded at www.mstube.com/customer-downloads/.

Material Substance Content: All products shipped by Michigan Seamless Tube contain a chemical analysis supplied by the original raw material supplier that can be used for material substance reporting, if desired. This chemical analysis is not required by the REACH directive, but is openly provided.
